Fresh off a successful fundraiser, this year's Leadership Blair County Adult class is reflecting on the power of teamwork. In April, they held a 200 Club Fundraiser at the Bavarian Aid Society to benefit Easter for Eli, an organization that collects and distributes Easter baskets to children and their families in hospitals.

Courtney Hornung, Senior Program Manager at Blair Image Elements, noted that the event exceeded her expectations. However, planning faced challenges, particularly a last-minute change to the benefactor, requiring the class to select a new one about six weeks before the event.

Kyle Sarver, Staff Scientist at Keystone Environmental Health and Safety Services, said, "The unexpected change was probably the biggest challenge." He added, "Having to pivot while keeping our enthusiasm was a struggle, but we came together to create an 'above and beyond' experience."

Anthony Augustine, Fleet Foreman at Ward Transportation and Logistics, expressed pride in his classmates, saying the circumstances helped the group grow as a team.

"I'm proud of my LBC classmates. I would bet there isn't a better group that could do it than us," he said. The class plans to formally present the donation to Easter for Eli in June.

Unlocking Growth: The SBA 504 Loan Program and its benefits

The U.S. Small Business Administration (SBA) 504 loan program is a powerful financing tool designed to help small businesses grow while supporting local economic development. Administered by the SBA, this program provides long-term, fixed-rate financing for major fixed assets like commercial real estate, equipment, and facility upgrades. Altoona-Blair County Development Corporation is your local Certified Development Company (CDC) and one of eight in the state that works with local businesses on SBA 504 loan requests.

SBA 504 projects include three parties: the business owner, who contributes 10% of the total project cost, a CDC funded by the SBA providing 40%, and a private lender covering the remaining 50%. If the business is a start-up business and/or the property is considered special-purpose, an additional 5% is required from the Borrower for each of these instances. The typical SBA 504 model allows business owners to pre-

serve working capital while locking in below-market interest rates fixed for up to 25 years. The interest rate is set by the SBA monthly and the current interest rate for 25 year-term loans is approximately 6.4% fixed for the life of the loan.

Beyond benefiting individual businesses, the 504 program has a ripple effect on local economies. By enabling businesses to purchase property, expand operations, or invest in new equipment, it fuels job creation and revitalizes communities.
